**Background Information** 

iTRAK is a standalone system used as an internal investigative analysis tool with the Special Emphasis Investigations Team (SEIT). iTRAK's capability as a comprehensive repository system is designed to support employees to capture, control, and analyze multi-source data. Users can add, delete, import and/or export records and reports as needed in support of investigative work. Creation of a record occurs during the onset of an investigation.

SEIT receives investigative requests via email, phone calls and/or regular mail. Employees enter preliminary data into iTRAK, at which point iTRAK assigns each investigation a unique case number. The types of cases SEIT investigates include: illegal and/or nefarious operations in the National Air Space (NAS), illegal charter aircraft operations, FAA Hotline Complaints, Whistleblower Complaints, designee investigations, criminal violations, and/or assist law enforcement agencies involving Federal aeronautical statutes. Data captured by iTRAK may include PII information, names, addresses, airman certificate numbers.
