Each program website, listed below, is only accessible to eligible employees with a signed Non-Disclosure Agreement or other appropriate permissions. Safety Program Event Review Committees (ERCs) and analysts track and trend this confidential information.</p> <p>The VSRPs enable the parties to have access to valuable safety information that may not otherwise be obtainable. The collected information is reviewed and analyzed to facilitate early detection and improved awareness of operational deficiencies and adverse trends. The information specified in employee reports is used to develop skill enhancement training or system corrective action to help solve safety issues and possibly eliminate deviations from, and deficiencies in, applicable air traffic control directives.</p>
