Background Information

This schedule covers the EEBACS system in the FHWA Federal Lands Highway (FLH) Divisions EEBACS is used by all three FLH Divisions Eastern, Central, and Western EEBACS is a system that provides for estimation, solicitation/award, and contract administration of FLH's highway/bridge construction projects. It consists of a series of components that track the costs of highway construction from the project's inception through construction and final acceptance of the project by our partners.

EEBACS is not the official documentation for the Final Construction Reports data (disposition authority N1-406-09-2, item 4a). All official contract actions, modifications, change orders, etc. are completed outside the system using the current paper processes and are just tracked within EEBACS (and possibly scanned copies are uploaded into EEBACS). The permanent Final Construction Records for the Federal Lands Highway Projects Files are not being stored in EEBACS.

There is some data in EEBACS that may replace paper documents, such as the Construction Daily Reports and Construction Daily Diaries, however, these documents fall under Supplemental Documentation which has a temporary disposition (authority N1-406-09-2, item 4b) Thus, in order to comply for the EEBACS Master files category, we listed the disposition as "Delete or destroy after 10 years after the cut-off or when the agency determines that they are no longer needed"
