The Appian platform hosts all modules in the same PaaS environment to leverage common resources and components across the modules. The TrIAD modules are presented in a unified web-based graphical user interface (GUI), and used by FTA employees and contractors, and organization and external users. Organization users include officials of State and local transit agencies. External users include auditors, contractors, and US Department of Labor (DOL) offices charged with oversight of transit agency compliance with federal labor laws.

Item Description	"The Bureau of Transportation Statistics (BTS) module enables grantee organizations to review the opportunity to provide links to their publicly-available transit map data, including stops, routes, and schedules, for use in the National Transit Map (NTM). The module enables grantees to authorize or decline a Creative Commons (CC) Attribute 3.0 US license to their transit map data. After the grantee user assents or declines to grant the CC license, the TrIAD BTS module compiles the data in transmissible format, and sends an email with the loaded links to the DOT Office of Research and Technology (OST-R) Bureau of Transportation Statistics (BTS). The TrIAD BTS module uses the grantee's TrIAD NTD ID for grantee user identification. The TrIAD BTS module does not store any information related to the event.
	After receiving the TrIAD BTS email, the OST-R BTS uploads the related grantee transit maps and map data and consolidates it in their National Transportation Atlas Database (NTAD) and NTM. The CC license is necessary to permit OST-R BTS to obtain and share the local transit mapping data in the NTM and NTAD. The OST-R BTS resources are outside the TrIAD system boundary. "
