1. NATIONAL TRANSIT DATABASE (NTD) FILES [Previously known as SECTION 15]. The National Transit Database records consist of detailed summaries of financial and operating data submitted to the Federal Transit Administration by the nation's mass transit systems. Extensive data are provided by approximately 600 of the nation's mass transit systems, including systems operated and/or administered by transit authorities, states, city departments and private operators under contract to public agencies. All applicants and direct beneficiaries of Federal assistance under Section 9 of the UMT Act are subject to the reporting system and the uniform system of accounts and records. The purpose of the NTD to assist in meeting the needs for information on which to base planning for public transportation services and to make public sector investment decisions at all levels of government.

- A. Inputs/Source Records. *GRS 20, item 2a*  
Inclusive Dates: July 1978 and thereafter  
Arrangement/Sort Statement: There is no special arrangement.  
Privacy Act Restrictions: There are no restrictions.

Disposition: Temporary. Destroy (paper records) after the information has been converted to an electronic medium and verified, or when no longer needed to support the reconstruction of, or serve as the backup to, the master/history file, whichever is later.

Disposition: Temporary. Delete (electronic records) when data have been entered into the master file or data base and verified, or when no longer required to support reconstruction of, or serve as back-up to, a master/history file or data base, whichever is later.
