ITEM NO. DESCRIPTION OF ITEM & PROPOSED DISPOSITION

1. TEXAS STATE DATA. One of a collection of 27 states police reported accident data. Each state provides a census of all police accident reports, annually. The State Data are used to support National Highway Traffic Safety Administration's (NHTSA) identification of traffic safety problems, development and implementation of vehicle and driver countermeasures, and evaluation of motor vehicle safety standards.

State police, local police, sheriffs and other enforcement officers in Texas fill out a Police Accident Report (PAR) for each motor vehicle accident resulting in \$250.00 worth of property damage, a personal injury, or a fatality. They record environmental and road conditions and accident, vehicle, and occupant characteristics. These reports are forwarded to the Texas Department of Public Safety who microfiche the hard copy and code data from the report onto a database containing reports from all police jurisdictions in the state. Texas uses these data to produce a report and analyze their highway safety and roadway problems. NHTSA obtains the data from the Texas Department of Public Safety and has used the data in many ways including to evaluate the relationship between injury severity measures obtained in the New Car Assessment Program and real-world crash experience and the relationship of car size to occupant injury in single-vehicle and two-vehicle crashes.

YEARS AVAILABLE: 1972, 1974 & thereafter

ARRANGEMENT STATEMENT: It is arranged by DPS Accident Number.

STATEMENT OF RESTRICTIONS: There are no restrictions.
