1. COMBINED SERVICE SEGMENT AND T-9 (DATA BANK 27T). These electronic files contain the Combined Service Segment and T-9 data for both Domestic and International markets. In general these files contain totals of passenger enplaned and transported for each pair of points served or scheduled to be served by a single stage of at least one flight within the reported time period. Data elements include airport numeric codes, airport alpha codes, carrier codes, carrier entity codes, service class, aircraft group code, aircraft type code, segment distance, number of total revenue departures performed from the base city, total number of first class seats available for all performances of segment, total number of coach seats available for all performances of segment, total time in minutes of flight, total number of passengers in first class service, total number of passengers in coach service, world area codes, number of first class revenue passengers who enplaned segment origin and deplaned at this point, number of coach revenue passengers who enplaned at segment origin and deplaned at this point, and repeating segment count. [1984 through 1989]

ARRANGEMENT STATEMENT: The data are arranged numerically by airport code.

STATEMENT OF RESTRICTIONS: 14 Code of Federal Regulations, Part 241 authorizes restrictions on public access to the confidential business information in the files.

CURRENT VOLUME: 3 REELS & 3 CARTRIDGES.

ESTIMATE OF ANNUAL ACCUMULATION: 0 REELS OR CARTRIDGES
