1.	<u>Airline Service Quality Performance Files</u>  These electronic files represent selected data that carriers with one percent or more of total domestic scheduled service passenger revenue are required to report monthly for their flights involving any airports that are within the contiguous 48 states that accounted for at least one percent of domestic scheduled passenger enplanements. Data elements include carrier, flight number, departure airport, arrival and elapsed flight time as shown by the Official Airline Guide (OAG) and the carriers' computer reservation system (CRS), carriers' actual performance, and selected differences among the three sources, such as departure delay and elapsed time difference. (September 1987 and thereafter)  a. Data File  Disposition: <b>Permanent</b> . Cutoff annually. Transfer a copy to the National Archives 2 months after the cutoff.	NI-467-93-01/1
