| 1. | <p>The National Vietnam Veterans Readjustment Study (NVVRS) records contain detailed information of the psychosocial status of Vietnam theater veterans, Vietnam-era veterans and a comparable civilian population. The data base contains family, educational, vocational, and marital histories including information pertaining to a veteran's military service. The data base also contains responses to several diagnostic mental health questionnaires as well as the results of psychological testing and clinical evaluations. Data pertaining to health and adjustment patterns of veterans' spouses and children are included in a selected subsample. Data were collected during 1986 and 1987, however, many parts of it are retrospective in nature.</p> <p>The NVVRS records consist of a final report, data base, and documentation specifications including a codebook that are integrally related to the data base. Files are hardware and software independent and written on half-inch magnetic tape in the American Standard Code for Information Interchange (ASCII) format, without internal control characters, on 9 track open-reel tapes, recorded at 6250 bytes per inch.</p> | | |
