OEP Circulars, Bureau of Budget Bulletins, memorandums, reports, studies, budget

estimates, functional statements, and drafts documenting OEP efforts to fight inflation, to devote more attention to the economic problems facing the nation caused by spending for the Vietnam War, to re-organize more efficiently, to develop a five year plan, and to satisfy President Johnson's call to "modernize and streamline" the Federal Government. Sample reports include "Alternative Approaches to Central Programming" and "Civil Government and Public Morale." The Committee was responsible for the policy direction, coordination, and surveillance of the Oil Import Program. Subjects examined in the Working Group meetings, and included in this series, are the Oil Import Program, oil imports and exports, and factors affecting the supply and demand of oil.

Its accomplishments include the development of a set of recommendations to further Federal-State cooperation in telecommunications management.
