1. MISCELLANEOUS APO CORRESPONDENCE FILES ("Correspondence bearing on war matters"), ca. 1942-ca. 1952. 1 cubic foot. Arranged by type (eg. supervisory, clerk, carrier, auxiliary) and thereunder chronologically.

Correspondence relating to postal activities and operations during World War II, including establishment and discontinuance of APOs and the transfer of the Fleet Post Office to the Post Office Department after World War II ended. Some of the records bear "Secret" markings, but many have been stamped "Declassified."

**PERMANENT.** Transfer immediately to the National Archives--Pacific Sierra Region. The Archives will screen for permanent material (item 1) and destroy nonpermanent material (item 2).

2. WORLD WAR II DISCONTINUED APO FILES, 1942-1952. 2 cubic feet. Arranged by APO number and thereunder chronologically.

Correspondence, memorandums, and WD AGO form no. 951, "Nomination of Army Mail Clerk," for Army post office branches of the San Francisco Post Office. Primarily notices of nominations for assistant army mail clerks, with accompanying forms 951 documenting the effective date, filing of application for bond, and date and place of birth of nominee. Other records concern clerks ending their duty, issuance of keys, and establishment of money order units within particular APOs. In some cases a carbon copy memorandum concerning the establishment of a particular APO is included, but in other cases cross reference sheets refer to "the 'General Military' file" for this information. Information about the jurisdiction and operation of particular APOs is not included. Some of the records bear "Secret" markings, but many have been stamped "Declassified."

Letters received from congressmen, typically transmitting a constituent complaint regarding mail delivery, postal station service, etc., with letters documenting the post office's response.

4.    TRANSPORTATION OPERATING CONTRACT FILES, 1954-1963. 1 cubic foot.  
Arranged primarily by route number, but including files labeled "Cheli AFB."

Correspondence and memorandums concerning contracts with railroad companies for transportation of mail by rail or motor vehicle. Copies of agreements are occasionally included. The records relate to renewals, amendments, payments, timetables and changes in schedules, reports of volume carried, etc. A number of files relate to use of facilities at Cheli Air Force Base, including a diesel switch engine, during the Christmas holidays.
