	<p><b><u>Administrative Records of the Referral and Monitoring Agencies</u></b></p> <p>These are administrative records for Drug Addiction and Alcoholism of the Referral and Monitoring Agencies (RMAs). The Social Security Administration had entered into contractual agreements with RMAs to monitor the beneficiary treatment activities for SSA. Since the program has been terminated, RMAs no longer will retain these records.</p> <p>On March 29, 1996, the Contract with America Advancement Act of 1996 (Public Law 104-121) was enacted which prohibits Title II Disability Insurance and Title XVI Supplemental Security Income eligibility to those individuals whose drug addiction and/or alcoholism is a contributing factor material to the finding of disability. As a result of the legislation, the awarded contracts that the Social Security Administration had with the RMAs will be terminated effective December 31, 1996.</p> <p><u>Proposed Disposition:</u> Cut off upon termination of contracts on Dec. 31, 1996.  <del>Retain the records for 7 years; then destroy.</del>          Destroy 7 years after cut off. per telecon Bill White</p>
