	<p align="center"><u>RECORDS RETENTION AND DISPOSAL SCHEDULE</u> <u>BLACK LUNG X-RAY FILMS</u></p> <p>A file containing approximately 1,200 cubic feet of X-ray films of individuals applying for black lung benefits under Part B, Title IV, of the Federal Coal Mine Health and Safety Act, as amended. These films were, for the most part, purchased by SSA as part of consultative medical examinations for claimants alleging disability due to black lung disease or were submitted by these individuals as medical evidence. These X-rays must be retained as original medical documentation to be used by SSA should an individual request reopening under section 404.957(c) of the Code of Federal Regulations. Department of Labor (DOL) personnel will also directly access this file for the purpose of administering Part C, Title IV, of the Federal Coal Mine Health and Safety Act, as amended. Thus, the films must be available to both SSA and DOL personnel, as necessary. Approximately 40,000 films have already been transferred to Washington National Records Center (WNRC) and they will also be covered by this authority.</p> <p>Transfer immediately to WNRC. Destroy 10 years after transfer to WNRC.</p>
