Electronic Mail and Word Processing System Copies

Electronic copies of records that are created on electronic mail and word processing systems and used solely to generate a recordkeeping copy of the records covered by the other items in this schedule. Also includes electronic copies of records created on electronic mail and word processing systems that are maintained for updating, revision, or dissemination.

This disposition applies only to electronic copies related to all items in Appendix *with the exception of* Items 1801, 1802 and 1804. It has been determined that these series require individual analysis to determine the disposition for their related electronic copies. (N1-64-87-1, N1-64-90-1)

- a. Copies that have no further administrative value after the recordkeeping copy is made.
