These may be found in English and other languages, with originals in both paper and electronic form due to the nature of officially recognized records of other nations where the agency performs its mission. Examples include, but are not limited to: public laws, documents, contracts, treaties, boundary information, land use agreements, decrees or titles, correspondence, abstracts or certificate of title documenting Federal real, and excess property and asset ownership, usage, loans, partnerships, agreements, surveys, easements, rights-of-way, and chain of title for property the Government, acquired by purchase, condemnation, donation, exchange, or otherwise, acquired for the purpose of achieving the agency mission.</p> <p>Note: Records of structures built by ABMC are covered under a separate schedule.</p>
