## American Battle Monuments Commission (Record Group 117)

Described below are all remaining unscheduled records assigned to RG 117 at the Washington National Records Center. Often intermingled with the permanent records are disposable materials which cannot easily be removed until the records are transferred to the National Archives where they can be screened during archival processing. These are 5 x 7 inch forms. The "alphabetical" cards include the full name of the deceased soldier, the rank, the unit, the date of death, the race of the soldier, the state of residence, the service number, the name of the cemetery where the deceased is buried, the grave site location (row, block, and grave number), the decorations the soldier was awarded, and the name and address of the next of kin. The previous burial site of the deceased is also shown.

The "numerical" cards for the unknowns show only the name of the cemetery where the soldier was buried, the grave site location (row, block, and grave number), and the previous burial site of the deceased.

S. government civil service credit for foreign nationals employed by the ABMC European Regional Office. The letters are from the Secretary of the ABMC, the Research Division of the ABMC, and the American Embassy located at Paris, France.

Letters sent with attached tables and applications, relating to appropriations, budgets, and expenditures; the reconstruction of World War I cemeteries, monuments, and memorials which were damaged during World War II; personnel services; employment and retirement of ABMC personnel; retirement funds; and foreign nationals who applied to the U. S. Civil Service Commission for U. S. government civil service credit.

The records concern two controversies over whether the German government should pay for the reconstruction of the World War I cemeteries and whether foreign nationals should receive civil service status and benefits because they were employed by the U. S. federal government.
