WNRC Accession 122-71A2001, Boxes 15-33.</p> <p style="text-align: center;">INVESTIGATION OF COFFEE PRICES, 1954</p> <p>In 1953, a crisis developed in the domestic and international coffee trade, set in motion by reports of a cold wave and frost in Brazil. As a result, the price of coffee in the United States rose sharply resulting in a barrage of complaints from the public directed at many parts of the government, including the FTC. Along with these complaints came allegations of artificial restrictions on coffee supplies, of manipulations on the New York Coffee and Sugar Exchange influencing green-coffee prices, and of artificial and deliberate inflation of coffee prices from the green bean to the roasted product. As a result, the FTC resolved on January 26, 1954 to launch a comprehensive investigation into the coffee industry. The investigation was completed in the summer of 1954 and the final report was published and presented to Congress on July 29, 1954.</p>
