

**BUDGET ESTIMATES OF INTERSTATE  
COMMERCE COMMISSION (ICC)**

These records date from 1940 to 1995. They are estimates submitted to Congress in support of the ICC's annual Budget Requests. They illustrate the manner in which budget requests were prepared with meticulous attention to detail. Because of the detail these documents also illustrate how the agency was organized, the number of employees and the costs of the work done. The ICC was abolished in 1995 by the ICC Termination Act of 1995. These documents provide a unique understanding of how that agency conducted business.
