	<p><b><u>RATE BUREAU AGREEMENTS:</u></b></p> <p>Records filed with the Surface Transportation Board under new 49 U.S.C. 10706, Rate Agreements: exemption from antitrust laws and 49 U.S.C. 13703, Certain collective activities; exemption from antitrust laws, include railroad and motor carrier rate bureau agreements and amendments submitted for Board approval, confidential transcripts or sound recordings of rate bureau meetings and voting records, and shipper agreements with regard to compensation for the use by rail carriers of shipper-owned or leased rolling stock. Records were formerly filed with the Interstate Commerce Commission under 49 U.S.C. 10706(a) and (b). Section 10706(a) pertained to railroads and section 10706(b) pertained to motor carriers.</p> <p>Prior to 1976, motor and rail agreements were governed by section 5a of the Interstate Commerce Act (ICA). The Railroad Revitalization and Regulatory Reform Act of 1976, Pub. L. No. 94-210, 90 Stat. 31, amended section 5a of the ICA, effective November 1, 1976, by deleting reference to railroads, and enacted a new section 5b governing railroad collective ratemaking agreements. In 1978, sections 5a and 5b were recodified as 49 U.S.C. 10706(b) and 10706(a), respectively.</p> <p><del>Maintain at the Board for a period of 30 years, transfer to the Federal Center in 30-year blocks. Dispose of 30 years thereafter.</del></p> <p>*Cut off every three years and transfer to the Washington National Records Center.
