1.	<p><u>OPERATING RIGHTS DOCKETS CASE FILES</u></p> <p>Consists of public docket cases with the prefix of MC, FF and WC. These dockets resulted in grants, denials, dismissals, discontinuances, and withdrawals of operating authority to the applicant (either a motor carrier, a freight forwarder or water carrier, or a person) by the Interstate Commerce Commission. These dockets contain information on the organization, functions and operations of firms for which the certificates were issued.</p> <p>The authority issued, in the form of certificates licenses, or permits, describes routes, stops, jurisdictions, and the type of property to be transported. Operating authority represented a property right which could, on approval of the ICC, be sold or transferred to another carrier.</p> <p>The ICC was abolished by act on 12/29/95 (109 Stat.932). With the end of the ICC, the operating rights it granted became null and void. For this reason, the 50 year retention requirement of the previous schedule is inappropriate.</p>	NC1-134-85-2/2A
