	<p align="center"><b><u>RECORDS OF THE RAIL SERVICES PLANNING OFFICE</u></b></p> <p>The Rail Services Planning Office was established in the Interstate Commerce Commission by the Rail Reorganization Act of 1973 which concerns the restructuring of rail services in the Northeastern and Midwestern regions of the United States. The Office was to operate for five years and was instructed to review, analyze, and report on the Department of Transportation's rail services report and the United States Railway Association's preliminary system plan; to provide public counsel and other staff to collect and develop information to be considered by the United States Railway Association in devising its system; to assist states and local and regional transportation agencies in determining if particular rail services should be subsidized; and to define cost accounting terms for the Rail Services Continuation Subsidy Program.</p> <p>The Office held hearings soliciting opinion of government officials, shippers, manufacturers, wholesalers, retailers, consumers, and any other interested persons on the Department of Transportation and United States Railway Association Reports.</p> <p><i>Copy to Agency 4-8-76 BG-134; 4 items</i></p>

	<p>Then the Office issued its own reports based on the data collected in the public hearings, the "Evaluation of the Secretary of Transportation's Rail Services Report," the "Evaluation of the United States Railway Association Preliminary Systems Plan," and others.</p> <p>The Rail Services Planning Office was given permanent status by the Railroad Revitalization and Regulatory Reform Act of 1976 which authorized the Office to act for the Interstate Commerce Commission in analyzing and planning rail services and transportation regulation throughout the United States.</p> <p style="text-align: center;"><u>Section of Analysis and Evaluation</u></p> <p>1. <u>Transcripts File (1974 - 1976)</u></p> <p>Copies of transcripts produced from public hearings on the "Secretary of Transportation's Rail Services Report" and the United States Railroad Preliminary Plan. Includes testimony and comment given in public hearing by government officials, industrialists, and consumers interested in or affected by railroad restructuring in the Northeast and Midwest. Constitutes working file from which Rail Services Planning Office reports are published. Official copies of these transcripts are included in the Public Docket File. Arranged chronologically within name of city.</p> <p style="text-align: center;">Destroy when 2 years old.</p> <p>2. <u>Submissions File (1974 - 1976)</u></p> <p>Copies of testimony and comment taken by letter from government, business, labor, concerned citizens, and railroad firms interested in or affected by railroad restructuring in the Northeast and Midwest as proposed by the Department of Transportation and the United States Railway Association.
