1. MUSCLE SHOALS WATER PLANT OPERATING RECORDS

The TVA Water Plant at the Muscle Shoals reservation was built in the 1930's to provide a source of water for TVA's Muscle Shoals, Alabama, reservation. The Water Plant is part of the National Fertilizer and Environmental Research Center, Prototype Operations.

The Alabama Department of Environmental Management (ADEM) requires the Water Plant to retain operating information contained on the following forms: TVA 5625, Residual Chlorine Tests; TVA 5628, Filter Log; TVA 5630, Daily Filter Report - Water Plant; TVA 29111, Hourly Tap Water Readings (Turbidity, PH-Residual Chlorine); and TVA 29210, Daily Turbidity Log Sheet. A written procedure provided by ADEM is followed by the Water Plant operators. The procedure requires any system utilizing surface water to complete daily log sheets for each shift. All records/forms containing bacteriological and chemical analyses; water production; ground water level information; filter operation records; distribution pressure requirements records; and water loss information records are completed and filed with ADEM weekly. TVA maintains their copies of these forms, filed chronologically, for 5 calendar years as required by ADEM procedures.

DISPOSITION

Destroy when 5 calendar years old as required by ADEM procedures.
