1. TVA NEWS VIDEO TAPES

This series contains video tapes of news stories regarding TVA for the approximate period 1985-88. TVA's Media Relations Staff recorded the evening news of the three local network channels (ABC, CBS, and NBC) each day during this period, including the local news and national news. There is a much smaller volume of national news. The next day all news regarding TVA was copied onto another tape. There are approximately 50 3/4-inch U-Matic video tapes that are indexed by date, but not by subject.

The period of 1985-88 was a significant era in TVA history. During this period all of TVA's nuclear power plants were shut down because of safety concerns. Employees were alleging that they had been discriminated against because they identified safety problems, and TVA ultimately contracted out the management of the nuclear power program. All of these issues were very controversial and were heavily reported by the news media.
