#### WIND ENERGY FILES

This material describes the support services provided by Data Services Branch, Field Operations Branch, and Computer Systems Development Branch for Solar Applications Branch programs in support of Wind Energy and Solar Homes Monitoring Programs. Specifically, the material includes Data Recovery Summary Reports, Progress Reports, Problem Status Reports, Trouble Reports, Administrative information, Budget Reports, Anemometer Loan Program information, Bid Packages, and Station Documentation and pictures of TVA wind mills and wind turbines. The inclusive dates are December 1980 to October 1986, and the volume is 4 cubic feet.

This information is historical data since the Solar Applications Branch was disbanded within a short time after the project was cancelled. The information will be valuable to TVA or the public in the future if an emphasis is once again placed on alternative forms of energy generation.
