Included are sketches of unique shop fabrications as well as manufacturer's drawings. They provide a comprehensive picture of items used for research and development and are continually referenced for fabrication, maintenance, alteration, repair, and duplication purposes.</p> <p>As a part of OACD's cooperative research and development program, TVA processes for fertilizer production are made available to others including underdeveloped countries. When these processes are shared with others, it is imperative that they receive all related information including copies of these sketches and drawings. These records are filed by size, then number and are located by an index card system filed by subject.
