Background Information

The Military Selective Service Act, Selective Service regulations, and the President's Proclamation on Registration requires those registering with Selective Service to provide their full name, date of birth, address, sex, Social Security Account Number, if they have one, and their signature. The principal purpose of the requested information is to establish or verify a person's registration with the Selective Service System. The RCV system allows men, age 18 through 25, living in the United States, with a social security number, to register on-line with Selective Service. The RCV database is 861 GB and grows by 49 GB /year. RCV contains records for men born after 1959 who registered with Selective Service. Records include a man's name, address, Social Security number, date of birth, Selective Service number, and date of registration. RCV includes all records for men born after 1959 who were required to register for a possible military draft. Draft registration was reinstated July 2, 1980, and the registration requirement pertained to men born in 1960 or later. The RCV database has 512 million records with names in them. This count includes records that share the same name with other records. Also, the count includes records with invalid names that could come in from various sources. SSS will keep records until the registrant is 85 years old. After that, records can be purged from RCV. This has not occurred yet with the current system because no one on record has reached that age. RCV currently doesn't apply records management features like cutting off records and moving them to inactive status, or flagging them in some way, but that functionality could be added to the system if needed. The system also allows U.S. male citizens living OUTSIDE the United States with a valid social security number the opportunity to register on-line. Participants without a social security number, and immigrant males (documented or undocumented) that are not able to register online should register



by filling out a SSS form 1 (Selective Service System Registration Form). On-line registration and access to SSS form 1 can be obtained by going to www.sss.gov.
