Background Information	<p>The Military Compensation and Retirement Modernization Commission (MCRMC) is an independent executive branch Commission established to study and provide recommendations to modernize military compensation and retirement. Established by the National Defense Authorization Act (NDAA) for Fiscal Year 2013, this nine-member Commission was mandated to provide the President of the United States and the Congress specific recommendations to modernize pay and benefits of the Uniformed Services. Section 671 required the Commission's recommendations be made to "ensure the long-term viability of the All-Volunteer Force by sustaining the required human resources of that force during all levels of conflict and economic conditions; enable the quality of life for members of the Armed Forces and the other uniformed services and their families in a manner that fosters successful recruitment, retention, and careers for members of the Armed Forces and the other uniformed services; and modernize and achieve fiscal sustainability for the compensation and retirement systems for the Armed Forces and the other uniformed services for the 21st century."</p> <p>The Commission held hearings and town halls, met with various stakeholders, visited CONUS/OCNUS installations, conducted online surveys, and examined laws, policies, and practices of the Federal Government that result in direct payment of authorized or appropriated funds to current and former members (veteran and retired) of the uniformed services, including the reserve components of those services and their families.</p>

The Commission issued an interim report and a final report. The final report to the President of the United States, delivered on January 28, 2015, included findings and specific recommendations for modernizing military pay and retirement systems. The Commission terminates on December 31, 2015.
