Background Information The Dwight D. Eisenhower Commission was created by Congress (P.L. 106-79) to perpetuate the memory and contributions of President Eisenhower as the Supreme Commander of the Allied Forces in Europe during World War II and as the 34th President of the United States. The legislation authorizing the construction of a memorial on Federal land in the District of Columbia was signed by President William J. Clinton on October 25, 1999. The law established a 12-member commission, four of whom were to be appointed by the President, four by the Senate (equally split between both political parties), and four by the House (equally split between both political parties). The law provided for a chair and vice-chair -- they could not be members of the same party.

After several years of hearings and several design changes, the final design was approved in 2015. Ground breaking on the four acre site occurred on November 2, 2017. The dedication is scheduled for May 8, 2020, the 75th anniversary of Victory in Europe Day.
