Description:

The National Surface Transportation Policy and Revenue Study Commission was established under the Department of Transportation by Section 1909 of the Safe, Accountable, Flexible, Efficient Transportation Equity Act-A Legacy for Users (SAFETEA-LU) (119 Stat. 1144), approved August 10, 2005. The Commission was created because, as Congress declared, "it is in the national interest to preserve and enhance the surface transportation system to meet the needs of the United States for the 21st century." The Commission submitted its final report to Congress on January 15, 2008 and closed its doors on July 7, 2008.

	<p>This schedule provides disposition authority for the records of the National Surface Transportation Policy and Revenue Study Commission.</p> <p>Congress created The National Surface Transportation Policy and Revenue Study Commission on August 10, 2005, under Public Law (PL) 109-59, Section 1909, of the Safe, Accountable, Flexible, Efficient Transportation Equity Act—A Legacy for Users (SAFETEA-LU). The Commission was created because, as Congress declared, "it is in the national interest to preserve and enhance the surface transportation system to meet the needs of the United States for the 21st century."</p> <p>The Commission is comprised of 12 members, representing: Federal, state and local governments; metropolitan planning organizations; transportation-related industries; and public interest organizations. The Chairperson is the United States Secretary of Transportation. The Commission is working to examine not only the condition and future needs of the nation's surface transportation system, but also short and long-term alternatives to replace or supplement the fuel tax as the principal revenue source to support the Highway Trust Fund over the next 30 years.</p> <p>Beginning in May 2006, the Commission met regularly to hear about the challenges facing America's surface transportation network. Commissioners heard testimony</p>		

from national transportation advocates, policymakers, industry, labor, and from the general public.

Commissioners held ten field hearings around the country to learn about regional issues and dynamics that affect America's transportation system. Field hearings were held in Atlanta, Chicago, Dallas, Las Vegas, Los Angeles, Memphis, Minneapolis-St. Paul, New York, Portland, and Washington, D.C.

The Commission also authorized the creation of a 77-member Blue Ribbon Panel of Transportation Experts to provide "big ideas" on improving the transportation network. This Blue Ribbon Panel included experts from all levels of government, the private sector, industry, labor, and academic and research institutions.

The Commission submitted its report to Congress on December 31, 2007. The Commission will expire six months after that date.

Since the Commission was not established under Federal Advisory Committee Act (FACA), the National Archives and Records Administration (NARA) has advised the Commission that some Commission records are not covered by the General Records Schedules (GRS). Therefore, this request for disposition authority is for those records not already covered by the GRS.
