Nem 35. Audit Reports and Management Letters.

Audited financial statements of each gaming operation on Indian lands submitted pursuant to 25 CFR Part 571. Files include audit reports submitted by gaming operations, financial statements or accountings submitted by gaming operations, and management letters submitted by gaming operations that set forth the results of the actual audit. Tribes are to submit reports within 120 days of the fiscal year end of each gaming operation.
