Description:

President's Committee on War Relief Agencies established by Presidential appointment, March 13, 1941, to coordinate the activities of war relief agencies that were exempted from registration and reporting requirements of the Neutrality Act of 1939 (54 Stat. 4). Redesignated President's War Relief Control Board by EO 9205, July 25, 1942, to supervise and regulate all war-related relief agencies except the American National Red Cross and established religious bodies engaged in war relief. Terminated, effective May 15, 1946, by EO 9723, May 14, 1946, with functions assumed by the Advisory Committee on Voluntary Foreign Aid (ACVFA).
