United States Commission on Improving the Effectiveness of the United Nations Attachment to 115-109

In 1987, Congress created the United States Commission on Improving the Effectiveness of the United Nations to examine the United Nations as a whole; evaluate its strengths and weaknesses; and to make recommendations to the President and Congress on ways to improve the effectiveness of the United Nations and the role of the United States in the United Nations. The Commission is bipartisan and is comprised of four presidential appointees, two U.S. Senators, two Congressmen, and eight members of the public appointed by the Congress.

The Commission holds hearings and meetings around the country. Each is designed to hear the views of expert witnesses and members of the general public. In addition, the Commission is consulting with other private and public institutions and organizations engaged in efforts to reform the United Nations system, including efforts being made directly under the auspices of the United Nations.

Through the release of a final report, the Commission will make recommendations to the President and Congress on how to improve the effectiveness of the United Nations and the role of the United States in the United Nations. It is expected that the recommendations contained in this report will form the basis for legislative proposals concerning the United Nations.
