Description:

The President's Committee on Consumer Interests (PCCI) was established in the Executive Office of the President by Executive Order 11136 on January 3, 1964, as an advisory body consisting of both federal agency representatives and private citizens, with the the Consumer Advisory Council (CAC) designated the private-sector element. The Committee was amended by Executive Order 11349 of May 1, 1967. The PCCI was abolished by Executive Order 11583 on February 24, 1971 and many of the responsibilities of the Committee were transferred to the U.S. Office of Consumer Affairs, which was established by the same Executive Order 11583.

The President's Committee on Consumer Interests
Attachment to SF 115-109

The President's Committee on Consumer Interests was established by Executive Order #11136 on January 3, 1964. This order also established the Consumer Advisory Council. The function of the Committee was to consider the federal policies and programs of primary importance to consumers or the unmet consumer needs which could appropriately be met through Federal action, either under existing laws or new legislation.

The Committee studied the plans and programs of federal agencies affecting consumer interests. The Committee made recommendations to the President on questions of policy related to consumer affairs; conducted studies of matters related to consumer interests; and encouraged and assisted federal agencies to accomplish effective coordination of plans and programs affecting consumers. The President's Committee on Consumer Interests was abolished with Executive Order #11583 on February 24, 1971.

The Lyndon Baines Johnson Presidential Library is the official repository of this Committee's records: 135 linear ft and 38 rolls of microfilm, 1962 - 1969. The following series are currently stored at the Washington National Record Center.

1. **Consumer Correspondence Files.** WNRC Acc. No. W220-70A4364, Boxes ¹⁻¹⁴ ~~18-76-56-3-4 to 18-76-56-5~~. Incoming and outgoing correspondence from private citizens and companies to the President's Committee on Consumer Interests, discussing such public concerns as food additives, cancer, canned goods, contamination, diet and dietary food, cosmetics and toiletries, drugs/pharmaceuticals/vitamins, fire control, fish inspection, flammable fabrics, food quality, pesticides, meat inspection, mortgages (Box 1: Health, Safety, and Welfare), and other topics. Some topics received such a great response from the public that they take up an entire cubic foot (Box 2: Housing; Box 3: Automobile; Box 8: Appliances; and other topics). Most (ca. 65%) correspondence consists of copies: the original in-coming was sent on to the appropriate government agency that could respond to the query, and the original response from the Committee was sent to the correspondent. Arranged alphabetically by topic. Records date from late 1967 to late 1968. The volume on hand is 14 cubic feet.

Disposition: Temporary. Destroy upon approval of this schedule.
