Federal entities may cease operations when they are established as a temporary entity, are abolished, or functions are transferred to state or local government or private control.

Description:

On October 6, 1992 the measure was signed into law when the President signed H.R. 5488 (P.L. 102-393) or the Treasury, Postal Service and General Government Appropriations Act. The Commission was required to report to Congress by December 31, 1993. However, in 1993, Congress extended the due date for the final report until December 31, 1994, as part of the Treasury Department appropriations legislation (P.L. 103-123). The Commission released the report on December 29, 1994. The Commission terminated January 31, 1995.
