On April 29, 1992, following the not-guilty verdicts in the Rodney King beating trial, civil unrest erupted in the city of Los Angeles, California. The riots continued for five days, resulting in a profound loss of human life and destruction of property. In response, President George Bush established the Presidential Task Force on Los Angeles Recovery on May 4. The Task Force was given the responsibility of coordinating efforts of numerous Federal agencies to deal with the crisis. It was not reappointed by President Bill Clinton and therefore officially terminated on January 20, 1993
