However, an additional executive order extended the Committee's operation until October 31, 1997, when the Committee's final supplemental report was submitted.

The committee members have expertise relevant to the functions of the committee and are appointed by the President from non-Federal sectors. The Committee will terminate January 31, 1997.</p>
