## Description:

National Commission on the Observance of International Women's Year was established by EO 11832, January 9, 1975, to promote nationwide observance of IWY. Termination date extended to June 30, 1976, by EO 11889, November 25, 1975. Report on IWY activities submitted June 1976, and published as "To Form a More Perfect Union...": Justice for American Women. Commission reauthorized by an act of December 23, 1975, and given responsibility for organizing and convening a national conference within two years. Convened National Women's Conference in Houston, TX, November 18-21, 1977. Terminated, March 31, 1978, following submission of final report, March 22, 1978, published as The Spirit of Houston.
