

## Verification for the Use of GRS 6.1, Email and other Electronic Messages Managed Under a Capstone Approach

**SECTION A: GENERAL BACKGROUND INFORMATION (GRS 6.1, item 010)**

This section captures general information about the agency and the scope of Capstone implementation. This ensures that all positions are appropriately identified and documented. As a general rule, each record group will require a separate form.
