### **AS 400 Legacy Application**

## **Description**

The AS 400 Legacy System is a browser based application that provides searching of historical insurance data. No actual documents reside in the AS 400 Legacy System. The system contains only metadata about documents, because the documents have been migrated to the EXIM Docs application.

The primary users of this application are former AS 400 users and they perform searches on old insurance policy data. Data is searched using Oracle Application Express. The application uses an Oracle database and contains 10G. The data in the system covers the time frame from April 1985 through May 2007. The CIO's Office maintains no data on usage because it is a read only application.

#### Master File

The Master File consists of metadata related to insurance policy data. Includes fields such as: policy type, endorsement information, (credit limits, special conditions, and other information), shipment and account activity, broker information, insurance information, and buyer information.

Searches can be performed on Policy Number, Policy Type, or Insured Name. Once data is retrieved users have read only access to the meta data, see attachment A for a listing of all data.

#### Disposition

Temporary - - Destroy 12 years after transaction has been terminated (finalized or cancelled).

Users have a limited ad-hoc reporting capability using Hyperion. (GRS 20, item 16).
