Background Information Accucare is a product designed to conduct the clinical standard Addiction Severity Index (ASI) assessments for Pretrial Services Agency (PSA) supervised defendants and CSOSA supervised offenders in CSOSA and PSA's respective substance abuse treatment divisions. AccuCare captures, processes, stores and transmits client data to generate a recommended treatment plan based on the (ASI) assessment model and ASI score. CSOSA/ PSA uses Accucare assessment data to determine the appropriate substance abuse treatment placement for defendants and offenders.
