Background Information PRISM is used to capture criminal history, health & demographic information, mental health & substance abuse history, personal references, drug test results and supervision compliance information of individuals arrested in the District of Columbia. PRISM also contains drug test results of respondents and other parties involved in D.C. Superior Family Court matters. The information is used to (1) assist the court in setting initial release conditions for individuals arrested in the District of Columbia; and (2) provided compliance information to the courts on defendants released under Pretrial supervision.
