## JUDICIAL CONFERENCE COMMITTEE RECORDS

The Judicial Conference of the United States is the principal governing and policy-making body, on the national level, concerned with the administration and operation of the United States Courts. The Conference consists of the Chief Justice of the United States, the chief judges of the 11 circuits, the Chief Judge of the Court of Claims, the Chief Judge of the Court of Customs and Patent Appeals, and a district judge from each circuit chosen for a term of 3 years by judges of the circuit at an annual Judicial Conference of the Circuit. Since 1948, at least two sessions a year have been held, the annual meeting in September and a special meeting in March. Special sessions of the Conference may be called by the Chief Justice, as necessary

The Judicial Conference functions largely through nationally organized committees Judicial

Conference Committees include the Executive Committee, permanent Standing Committees with subcommittees thereto, and Special Committees created for a particular purpose. Appointments to these committees are made by the Chief Justice from the Judiciary, law schools, and the bar for specified terms. There are committees organized to consider administrative matters, such as salaries, statistics, and budget, ongoing judicial business, such as rules of practice and procedure and court administration, and non-recurring business, such as bicentennial activities, standards of admission to practice in Federal courts, and other judicial issues of the day. Each committee meets prior to a session of the Conference to study legislative and other matters which have been referred to it. The Committee's recommendations are presented in the form of a report to the Committee Chairman to the next meeting of the Conference

Currently, the only NARA holdings relating to the Judicial Conference are part of RG 116, and covered by Job # NCI-116-80-3 items 1-4 The records of RG 116 pertaining to the Judicial Conference consist, as per the disposition instructions, entirely of Official committee files which includes agenda, final reports, studies, selected correspondence and memoranda, subcommittee files, and related documents and minutes of committee meetings. All committee personnel files, as well as working papers, drafts, background material, and miscellaneous correspondence was disposable.

The above information pertaining to RG 116, relates to RG 276 because the records relating to the Judicial Conference in RG 276 are not a duplicate of those in RG 116. Instead, they are a result of the documentation of the U.S. Court of Appeals for the District of Columbia's presence and work at this Conference. They may add background information to an already existing series in our holdings and trace work performed by U.S. Court of Appeals for the District of Columbia (and be scheduled as permanent.)
